repress militarily any secessionist movement, while simultaneously forging a range of civilian administrative and institutional arrangements that attempt to address the grievances of disaffected populations. The book highlights key strategic and tactical innovations that the Indian Army and security forces made to deal with a range of insurgent movements. Simultaneously, it also examines how the civilian-military nexus enabled India's policy makers to utilize existing, and formulate novel, institutional means to address extant political grievances. India has been most successful where it has managed to use calibrated force, obtained the trust of much of the aggrieved population and made persuasive commitments to political and institutional reform. Examination of these elements of India's counterinsurgency performance can be compared to counterinsurgency doctrine developed by other countries, including the United States, and thus yield comparative policy prescriptions and recommendations that can be applied to other counterinsurgency contexts.
